QUALIFICATIONS

The qualifying equipment must be installed in a Arkansas home or business served with natural gas from Arkansas Western Gas Company and must meet the following efficiencies.

TECHNOLOGY	REBATE AMOUNT
Natural gas forced-air furnaces	90 to 94.9% AFUE (\$250 rebate)
Natural gas forced-air furnaces	95% AFUE or higher (\$350 rebate)
Direct vent wall furnace	80% AFUE or higher (\$250 rebate)
Hydronic heating systems	82% AFU or higher (\$350 rebate)

Rebate offer applies only to new natural gas furnaces and hydronic heating systems.

Arkansas Western Gas Company uses AHRI (Air Conditioning, Heating & Refrigeration Institute) listings to determine the efficiency of the equipment.

Heating dealers are not eligible to receive their customer's rebate.

Building contractors should negotiate with homeowners to determine who receives the rebate.

Equipment installed under warranty replacement does not qualify for the rebate.

APPLICATION REQUIREMENTS

The rebate application form must be submitted within 90 days of installation date or postmarked by June 30, 2011 whichever comes first! Application must be completely filled out with purchaser information, equipment information (including brand, complete model number, serial number, installation date and AFUE rating) and dealer and installer information. Arkansas Western Gas Company is unable to accept applications that do not include all this information. A copy of the dated invoice or sales receipt must accompany the completed rebate application and must include the following information: brand, complete model number and serial number. It is the responsibility of the dealer and purchaser to ensure that the installed equipment qualifies for the rebate. If it does not qualify, no rebate will be paid.

Arkansas Western Gas Company reserves the right to inspect the installed equipment.

Rebate qualifications and amounts are subject to change. Rebate funds are limited. Completed rebate forms will be processed in the order in which they are received. Arkansas Western Gas Company rebate programs may be cancelled or changed at any time.

This program ends June 30, 2011.

Rebates will not be paid if funds are depleted prior to June 30, 2011.

REBATE DETAILS

Rebate amounts will be issued for equipment installed between June 1, 2010 and June 30, 2011 only. Arkansas Western Gas Company issues cash rebates in the form of checks, not utility bill credits. Arkansas Western Gas Company is not responsible if the dealer does not provide accurate information about the amount of rebate or equipment eligibility. Rebate checks will be mailed within 4-6 weeks.
